ORDER OF PROCEDURE

On February 13, 1990, Western Kentucky Gas Company ("Western") filed an application with the Commission wherein it proposes to adjust its retail rates for service rendered on and after March 15, 1990.

The Commission finds that, pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to the proposed effective date.

IT IS THEREFORE ORDERED that:

1. The proposed rates hereby are suspended for 5 months from the proposed effective date, through August 15, 1990.
2. The procedural schedule listed in Appendix A, attached hereto and incorporated herein, shall be followed.
3. Western shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).
4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

5. Nothing contained herein shall prevent the Commission from entering a final decision in this case prior to the termination of the suspension period.

9. Public Hearings are to begin at 10:00 a.m., Eastern Daylight Time, in the Commission's offices at Frankfort, Kentucky, for the purpose of cross-examination of witnesses of Western, cross-examination of witnesses of intervenors, and the presentation of rebuttal testimony, if any.....6/20/90
