ORDER OF PROCEDURE

On March 30, 1990, Berea College Water Utility ("Berea") filed an application with the Commission wherein it proposes to adjust its water rates for service rendered on and after August 30, 1990.

The Commission finds that, pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to the proposed effective date.

IT IS THEREFORE ORDERED that:

1. The proposed rates hereby are suspended pursuant to KRS 278.190(5) through September 30, 1990.
2. The procedural schedule listed in Appendix A, attached hereto and incorporated herein, shall be followed.
3. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 12 copies to the Commission.


4. Berea shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.

8. Intervenors shall mail or deliver responses to requests for information, unless submitted sooner.....7/16/90
9. Public Hearings are to begin at 10:00 a.m., Eastern Daylight Time, in the Commission's offices at Frankfort, Kentucky, for the purpose of cross-examination of witnesses of Berea, cross-examination of witnesses of intervenors, and the presentation of rebuttal testimony, if any.....7/31/90
