## ORDER

This matter arises upon motion of Columbia Gas of Kentucky, Inc. ("Columbia") filed September 11, 1990 stating that the parties to this proceeding have met for the purpose of exploring settlement of all of the issues raised in this case, that all parties of record support the motion; and requesting that in order to provide the time necessary to continue settlement discussions, the procedural schedule be suspended. Columbia states that all parties to this proceeding will report to the Commission no later than September 24, 1990 whether progress in settlement discussions continues. Columbia further warrants that if such progress does not continue, the procedural schedule could be reimplemented and further proceedings held in this matter. Columbia has agreed to extend the suspension date established by Commission Order until January 26, 1991.

IT IS THEREFORE ORDERED that the motion of Columbia for suspension of the procedural schedule is hereby granted and the procedural schedule established in this case is hereby suspended for two weeks until September 24, 1990.

IT IS FURTHER ORDERED that Columbia shall, no later than September 24, 1990, file a report detailing the progress of settlement discussions or a proposed settlement agreement signed by all parties. If a progress report is filed rather than a settlement agreement, the procedural schedule, attached hereto and incorporated herein as an Appendix, shall be implemented without further order of this Commission.
