O R D E R

On April 23, 1990, Nolin Rural Electric Cooperative Corporation ("Nolin") filed an application and notice of intent to reduce its electric rates on June 1, 1990 due to its sound financial condition. The proposed rate decrease will result in a \$576,497 reduction in Nolin's annual revenues.

Based on Nolin's application and being advised, the Commission finds that, pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed rates. A preliminary review of Nolin's financial exhibits indicate that its current earnings level is in excess of the level previously authorized by the Commission. Therefore, the Commission will allow Nolin's proposed rate reduction to become effective on June 1, 1990 as requested and will conduct further proceedings to determine whether additional rate reductions are necessary to achieve fair, just, and reasonable rates.

IT IS THEREFORE ORDERED that:

1. Nolin's proposed rate reduction be and it hereby is approved for service rendered on and after June 1, 1990.

2. Nolin shall provide public notice of the proposed rates in accordance with the provisions set out in 807 KAR 5:011, Section 8(2) and (3).

3. The procedural schedule listed in Appendix A, attached hereto and incorporated herein, shall be followed.

4. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 15 copies to the Commission.


5. Nolin shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).

6. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

7. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.


