O R D E R

On April 3, 1990, AmeriCall Systems of Louisville ("AmeriCall") filed a new proposed tariff designated PSC No. 2 and on April 5, 1990, First Revised Sheet No. 7 to be substituted in the April 3, 1990 filing and on April 17, 1990, First Revised Sheet No. 22 to be substituted in the April 3, 1990 filing. The proposed effective date of the tariff is May 3, 1990.

On April 30, 1990, AmeriCall filed additional revisions to its April 3, 1990 filing consisting of Sheet Nos. 3, 4, 5, 7, 8, 10, 17, 24, 25, 26, 27, 28, 29, 30, 32, and 33.

On April 17, 1990, AmeriCall filed revisions to its March 14, 1990 tariff filing in response to the Commission's April 13, 1990 Order. The Order had rejected First Revised Sheet 6.3 and First Revised Sheet 6.4 because they were not consistent with the rate restrictions in the Commission's Orders in Administrative Case No. 330<sup>1</sup> in that the rates in various mileage bands exceed AT&T

Communications of the South Central States, Inc.'s (AT&T's) maximum approved rates for those mileage bands. The sheets filed April 17, 1990 reflect AT&T's rates.

The Commission, having reviewed the proposed tariff sheets and the amended sheets and being otherwise sufficiently advised, HEREBY ORDERS that:

1. The proposed tariff sheets be accepted for service on and after the date of this Order pending further Orders in Case No. 89-132<sup>2</sup> and Administrative Case No. 330 except as set forth below.

2. First Revised Sheet No. 22 contains rates for intraLATA operator-assisted telephone calls. This sheet is approved only on an interim basis pending the outcome of the Commission's decisions in Case No. 89-132 and Administrative Case No. 330.

3. First Revised Sheet No. 22 shall be refiled within ten days of the date of this Order containing the rate of .35 cents for each additional minute in the 56-70 mileage band, instead of the .39 cents on the proposed sheet.

4. AmeriCall's proposed services entitled Direct WATS, Select WATS, Direct 800 Service, and Select 800 Service, involving special access serving arrangements, are capable of intraLATA call completion. These services appear to be generically similar to

services offered that have been approved by the Commission.<sup>3</sup> Accordingly, in conformance with other approved services capable of intraLATA call completion, the Commission will require AmeriCall to measure and report interstate and intrastate jurisdictional and interLATA and intraLATA usage associated with Direct WATS, Select WATS, Direct 800 service, and Select 800 service, and to file usage reports with the Commission on a quarterly basis. This measuring and reporting requirement is instituted pending the Commission's decision in Case No. 89-132.

5. The Commission's decision herein to accept First Revised Sheet No. 22 on an interim basis pending the outcome of Case No. 89-132 and Administrative Case No. 330 renders moot any further consideration of First Revised Sheet 6.3 and First Revised Sheet 6.4 filed on April 17, 1990.

6. Within ten days from the date of this Order, the tariff sheets, corrected to reflect the decisions herein, shall be signed by an officer of AmeriCall and refiled with an effective date of May 3, 1990.


