O R D E R

On May 7, 1990, West Marshall Water District ("West Marshall") filed its revised tariff sheet with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068. Subsequently, on May 21, 1990, West Marshall filed revised tariff sheets to correct a mathematical error made in its original filing.

The Commission, having reviewed the evidence of record and being sufficiently advised, is of the opinion and finds that:

1. West Marshall's supplier, Benton Water and Sewer System, increased its rate for wholesale water from 50 cents to 65 cents per 1,000 gallons effective with its May 15, 1990 billing.

2. West Marshall proposes to increase the rates to its customers effective June 1, 1990.

3. During the 12 months ending February 28, 1990, West Marshall purchased 15,984,000 gallons of water and sold 11,138,730 gallons.

4. West Marshall's calculations are correct and show that the increase in purchased water costs is \$2,398, resulting in a purchased water adjustment of 22 cents per 1,000 gallons.

5. The purchased water adjustment of 22 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

6. The tariff sheet filed by West Marshall is correct and should be approved as filed.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of 22 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are hereby approved for services rendered on and after June 1, 1990.

2. The tariff sheet filed by West Marshall is approved as filed.

3. Within 20 days of the date rates approved herein are placed into effect, West Marshall shall file a copy of the notice to its customers and verification that such notice has been given.



APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 90-113 DATED 6/01/90

The following rates and charges are prescribed for the customers in the area served by West Marshall Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Rates: Monthly

First 2,000 gallons	\$8.14 Minimum Bill
Next 3,000 gallons	2.97 per 1,000 gallons
Next 5,000 gallons	2.42 per 1,000 gallons
Next 10,000 gallons	2.15 per 1,000 gallons
Over 20,000 gallons	1.87 per 1,000 gallons
