ORDER OF PROCEDURE

On June 29, 1990, Henderson-Union Rural Electric Cooperative Corporation ("Henderson-Union") filed an application with the Commission wherein it proposes to adjust its electric rates for service rendered on and after August 1, 1990.

The Commission finds that further proceedings are necessary in order to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to the proposed effective date.

IT IS THEREFORE ORDERED that:

- 1. The proposed rates hereby are suspended pursuant to KRS 278.190(2) through January 1, 1991.
- 2. Henderson-Union shall provide public notice of the proposed rates in accordance with the provisions set out in 807 KAR 5:011, Section 8(2) and (3).
- 3. The procedural schedule listed in Appendix A, attached hereto and incorporated herein, shall be followed.

4. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 12 copies to the Commission.

5. Henderson-Union shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).

6. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

7. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
