IT IS ORDERED that Henderson-Union Rural Electric Cooperative Corporation ("Henderson-Union") shall file the original and 12 copies of the following information with the Commission, with copies to all parties of record, on or before August 16, 1990. Each item of the data requested should be tabbed and numbered. When several sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible.

1. Reference Exhibit 11, page 20 of 29, "Fuel Adjustment Charge." Provide information to show how this figure was derived by means of workpapers, computations, source documents, or other materials.

2. Reference Exhibit 11, page 21 of 29, "Fuel Adjustment Charge." Provide information to show how this figure was derived by means of workpapers, computations, source documents, or other materials.

3. Reference Exhibit 11, page 26 of 29. In column one, "KW used" there is a line entitled demand charge, normalized with a figure of 1,308,863. Show how this number is derived and list the figures for rural delivery points and industrial points separately.

4. Reference Exhibit 12, page 2 of 2, and Exhibit 14, page 10 of 10. Why is the increase in the Peabody Coal Company (Breckinridge) energy charge .0006 mills greater than the other industrial customers?

5. Reference Exhibit 14, all pages. Provide specific information on how the fuel amounts were calculated.

6. In Case No. 90-128, Big Rivers Electric Corporation's Notice of Changes in Rates and Tariffs for Wholesale Electric Service, a time-of-day rate is proposed. (Exhibit 7, page 20 of 39) Explain in detail how Henderson-Union proposes to implement this tariff if the new rate is approved for Big Rivers Electric Corporation.
