O R D E R

On May 21, 1990, Fleming County Water Association, Inc. ("Fleming County") filed an application with the Commission for authority to establish and increase certain non-recurring charges as follows:

The Commission's review of this application was delayed because of Fleming County's failure to publish proper notice of its proposed charges to comply with Commission regulation 807 KAR 5:011, Section 10. Fleming County filed proof of compliance with the above regulation on September 13, 1990.

Fleming County has provided evidence of the individual expenses incurred to provide the services associated with the proposed charges except for the increased Membership Fee and Inspection By Association Fee. No cost justification or explanation was provided to justify a need for increasing these fees.

After reviewing the evidence and being sufficiently advised, the Commission finds that the proposed charges for which cost justification was provided are equal to the expenses incurred to provide the associated services. It further finds that the proposed charges as set forth in Appendix A to this Order are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The charges in Appendix A, attached hereto and incorporated herein, are approved for service rendered by Fleming County on and after the date of this Order.

2. The proposed increases in Fleming County's Membership Fee and Inspection By Association Fee be and they hereby are denied for the reasons stated above.

3. Within 30 days from the date of this Order, Fleming County shall file its revised tariff sheets setting out the charges approved herein.
