O R D E R

On August 14, 1990, Green River Electric Corporation, ("Green River") filed a motion requesting an enlargement of time until September 5, 1990 in which to answer the information request contained in the Order of the Commission dated August 8, 1990. In support of its motion, Green River states that several of the requests involve information which must be developed by or in consultation with Jack Gaines of Southern Engineering Company of Georgia, Green River's rate analyst in this case, and who is unavailable to assist Green River in responding until August 22, 1990.

Based on the motions and being advised, the Commission hereby finds that good cause has been shown to grant a limited extension of the due date for the requests which require direct input from Mr. Gaines. However, in recognition of the time constraints set forth in KRS 278.190, the Commission finds that the extension should be granted to August 29, 1990 on only those items that cannot be provided without assistance from Mr. Gaines. The remaining items, including at a minimum Items 1-17, should be filed on August 22, 1990 as previously ordered.


