O R D E R

On July 30, 1990, Jackson Purchase Electric Cooperative Corporation ("Jackson Purchase") filed an application to flow through any increase in rates granted its wholesale power supplier, Big Rivers Electric Corporation ("Big Rivers"), in Case No. 90-128.¹ Jackson Purchase did not request the approval of any additional revenues or margins in its application.

Jackson Purchase is one of four member-distribution cooperatives of Big Rivers. Based on the rates proposed by Big Rivers in Case No. 90-128, Jackson Purchase requested an increase of \$1,172,578. The proposed increase would result in an overall increase of approximately 4.4 percent to Jackson Purchase's consumers.

A hearing was conducted on October 15, 1990 at the Commission's offices in Frankfort, Kentucky. The Utility and Rate Intervention Division of the Attorney General's Office participated as an intervenor.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. The actual increase allowed Big Rivers in Case No. 90-128 is \$6,935,978, which will result in an increase in power costs to Jackson Purchase of \$1,172,578.

2. Jackson Purchase should be allowed to recover its increased power costs of \$1,172,578.

3. The rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable, in the public interest, and should be authorized effective with service rendered on and after January 1, 1991.

IT IS THEREFORE ORDERED that:


1. Jackson Purchase be and it hereby is authorized to flow-through the increased power costs resulting from the rate increase granted its wholesale power supplier, Big Rivers, in Case No. 90-128.

2. The rates in Appendix A be and they hereby are authorized effective for service rendered on and after January 1, 1991.

3. Within 30 days of the date of this Order, Jackson Purchase shall file with this Commission its revised tariffs setting out the rates authorized herein.

MINIMUM MONTHLY CHARGE:

The minimum monthly charge under the above rate shall be \$32,112.00 where 3,000 KVA or less of transformer capacity is required. For consumers requiring more than 3,000 KVA of transformer capacity, the minimum charge shall be increased by \$.75 for each KVA or fraction thereof required above 3,000 KVA. Where it is necessary to extend or reinforce facilities in excess of standard service facilities, the minimum monthly charge may be increased to assure adequate compensation for the added facilities of one and one-half (1-1/2) percent per month of the total cost of the excess facilities as a facilities charge for which no power and energy would be delivered.
