O R D E R

On September 14, 1990, the Kentucky Cable Television Association, Inc. ("KCTA") filed a motion requesting an extension of time from September 24, 1990 to October 15, 1990 to file its testimony in this case. On September 18, 1990, Kentucky Industrial Utility Customers ("KIUC") filed a similar motion seeking an extension to October 1, 1990.

By Order entered September 21, 1990, the Commission granted, in part, a motion filed by the Attorney General, by and through his Utility and Rate Intervention Division ("AG"), to modify the procedural schedule. In that Order, the Commission extended the original procedural schedule to provide as follows: intervenors testimony to be filed no later than October 3, 1990; All requests for information to intervenors to be filed no later than October 15, 1990; and intervenors shall respond to requests for information no later than October 24, 1990. Based on that modification of the procedural schedule, the motions of KCTA and KIUC are moot.

IT IS THEREFORE ORDERED that the motions of KCTA and KIUC for an extension of time be and they hereby are denied as moot.

O R D E R

On September 14, 1990, the International Brotherhood of Electrical Workers, Local 2100 ("IBEW"), filed a motion for full intervention. The Commission notes that the pending rate application of the Louisville Gas and Electric Company was filed on June 29, 1990. Pursuant to the established procedural schedule, the time for discovery has expired and testimony on behalf of the intervenors is due on September 24, 1990.

Based on the motion and being advised, the Commission hereby finds that the motion of IBEW for full intervention should be granted subject to its acceptance of the procedural schedule as it now stands.

IT IS THEREFORE ORDERED that the motion for full intervention of the IBEW be and it hereby is granted subject to the existing procedural schedule.
