# ORDER

On August 21, 1990, B & H, Incorporated ("B & H") filed an application for Commission approval of a proposed increase in its rates for sewer service. B & H proposed rates for sewer service which would generate additional annual revenues of \$7,107, an increase of 34 percent.

In October 1990, the Commission Staff conducted a field review of B & H's test-period financial records. Based upon this review, Commission Staff issued a report on December 4, 1990 recommending a \$5,989 increase in B & H's annual operating revenues for sewer service.

By letter dated December 4, 1990, the Commission advised B & H that comments on the Staff Report or requests for a public hearing must be submitted no later than December 19, 1990 or this case would stand submitted to the Commission for decision. B & H responded by letter received December 12, 1990 to advise the Commission that no public hearing was requested and Staff's recommendations were accepted by B & H.

The Commission, after consideration of the evidence of record and being advised, finds that:

- 1. The recommendations and findings contained in the Staff Report are supported by the evidence of record, are reasonable, and are hereby adopted as the findings of the Commission in this proceeding and are incorporated by reference as if fully set out herein.
- 2. The rates in Appendix A, which is attached hereto and incoroprated herein, are the fair, just, and reasonable rates for B & H and will produce gross annual revenues of approximately \$26,878 for sewer service based on adjusted test year revenues. These rates will allow B & H sufficient revenues to meet its operating expenses and provide for future growth equity.
- 3. The rates proposed by B & H would produce revenue increases in excess of that found reasonable herein and should be denied upon application of KRS 278.030.

### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by B & H in its application are hereby denied.
- 2. The rates in Appendix A are approved for services rendered by B & H on and after the date of this Order.
- 3. Within 30 days of the date of this Order, B & H shall file with the Commission its revised tariff setting out the rates approved herein.
