O R D E R

On August 13, 1990, North Manchester Water Association ("North Manchester") filed its revised tariff sheet with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds that:

1. North Manchester's supplier, Manchester Water Works, increased its rate for wholesale water from \$1.25 to \$1.50 per 1,000 gallons effective with the July 1990 billing.

2. North Manchester increased the rates to its customers, effective August 20, 1990.

3. During the 12 months ending July 31, 1990, North Manchester purchased 77,975,900 gallons of water and sold 65,910,920 gallons.

4. North Manchester's calculations are correct and show an increase in purchased water costs of \$19,494, resulting in a purchased water adjustment of 30 cents per 1,000 gallons.

5. The purchased water adjustment of 30 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

6. The tariff sheet filed by North Manchester is correct and should be approved as filed.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 30 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are hereby approved for services rendered on and after August 20, 1990.

2. The tariff sheet filed by North Manchester is approved as filed.


3. Within 20 days of the date of this Order, North Manchester shall file a copy of the notice to its customers and verification that such notice has been given.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 90-234 DATED August 29, 1990

The following rates and charges are prescribed for the customers in the area served by North Manchester Water Association. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Rates: Monthly

First 2,000 gallons	\$9.70 Minimum Bill
Next 3,000 gallons	3.15 per 1,000 gallons
Next 5,000 gallons	2.90 per 1,000 gallons
Next 15,000 gallons	2.60 per 1,000 gallons
Over 25,000 gallons	2.15 per 1,000 gallons

1 Inch Meter

First 5,000 gallons	\$19.15 Minimum Bill
Next 5,000 gallons	2.90 per 1,000 gallons
Next 15,000 gallons	2.60 per 1,000 gallons
Over 25,000 gallons	2.15 per 1,000 gallons

2 Inch Meter

First 15,000 gallons	\$46.65 Minimum Bill
Next 10,000 gallons	2.60 per 1,000 gallons
Over 25,000 gallons	2.15 per 1,000 gallons
