O R D E R

On August 10, 1987, the Commission issued its Order in Case No. 9918 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On March 4, 1991, Mt. Olivet Natural Gas Company, Inc. ("Mt. Olivet") notified the Commission that it had received a refund on January 24, 1991 from its supplier, Columbia Gas Transmission Corporation ("Transmission"), in the amount of \$654.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

(1) Mt. Olivet's notice of March 4, 1991 set out a refund factor of 9.41 cents per Mcf to refund \$654.

(2) The refund should begin with gas supplied on and after March 1, 1991 and should remain in effect for 1 month or until such time as the full amount has been returned to Mt. Olivet's customers.

IT IS THEREFORE ORDERED that:

(1) Mt. Olivet shall apply a 9.41 cent per Mcf refund factor to the approved rates beginning with gas supplied on and after March 1, 1991, which shall remain in effect for 1 month or until the total amount of the refund is returned to its customers.

(2) Within 30 days of the date the refund is terminated, Mt. Olivet shall file with this Commission a summary statement showing a reconciliation of customer billings and the amount refunded.

(3) The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with gas supplied on and after March 1, 1991, subject to refund.


(4) Within 30 days of the date of this Order, Mt. Olivet shall file with this Commission its revised tariffs setting out the refund factor authorized herein. All other rates and charges shall remain in full force and effect.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 9918-000 DATED 3/28/91

The following rates and charges are prescribed for the customers in the area served by Mt. Olivet Natural Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

***The above rates will be decreased by \$0.0941 per 1,000 cu. ft. according to the refund plan approved in Case No. 9918-000.
