O R D E R

On April 10, 1991, the Commission issued its Order in Case Nos. 10288-D and 10288-E approving the gas cost adjustment ("GCA") clause of Auxier Road Gas Company, Inc. ("Auxier"). The clause allowed for the quarterly adjustment in rates as set forth herein.

On November 22, 1991, Auxier filed its quarterly GCA, which is to become effective January 1, 1992 and is to remain in effect until April 1, 1992.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Auxier's notice of November 22, 1991 set out certain revisions in rates which Auxier proposed to place into effect, said rates being designed to pass on to its customers the wholesale decrease in gas costs from its suppliers. Auxier's expected gas cost ("EGC") for the quarter beginning January 1, 1992 is \$3.6389 per Mcf. It has been adjusted to reflect the most current cost of gas from Columbia Gas of Kentucky and to correct a computational error in Auxier's calculation of the expected gas cost from Presley Energy.

2. Auxier's notice set out no refund adjustment.

3. Auxier's notice set out a current quarter actual adjustment ("AA") in the amount of (4.7) cents per Mcf to compensate for over-recovery of gas cost through the operation of its gas cost recovery procedure during the months of July, August, and September 1991. The total AA of (1.4) cents per Mcf is designed to correct the current over-recovery, as well as under- and over-recoveries from 3 previous quarters.

4. The combined effect of the above adjustments is Auxier's gas cost recovery rate ("GCR") in the amount of \$3.6249 per Mcf, which is a decrease of 8.21 cents per Mcf from its last approved rates.

5. Auxier's corrected adjustment in rates, set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case Nos. 10288-D and 10288-E dated April 10, 1991 is fair, just, and reasonable, in the public interest, and should be effective with service rendered on and after January 1, 1992.

IT IS THEREFORE ORDERED that:


1. The rates proposed by Auxier are hereby denied.


2. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable, and are approved effective with service rendered on and after January 1, 1992.

3. Within 30 days of the date of this Order, Auxier shall file with this Commission its revised tariffs setting out the rates authorized herein.
