O R D E R

On June 27, 1990, the Commission issued its Order in Case No. 89-286 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On March 29, 1991, Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), filed its quarterly GCA, which is to become effective May 1, 1991 and is to remain in effect until July 31, 1991.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice of March 29, 1991 set out certain revisions in rates which Equitable proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale decrease in gas costs from its supplier in the amount of \$0.8282 per Dth. Equitable's expected gas cost ("EGC") for the quarter beginning May 1, 1991 is \$3.8092 per Mcf which includes a surcharge component of 80.54 cents per Mcf relating to the settlement of Kentucky West Virginia Gas Company Docket No. TQ

89-1-46-000, et. al. before the Federal Energy Regulatory Commission.

2. Equitable's notice set out a current quarter actual adjustment in the amount of (1.53) cents per Mcf to compensate for over-recovery of gas cost by the company through the operation of its gas cost recovery procedure during the months of November and December 1990 and January 1991. Equitable's previous quarter actual adjustment of (0.18) cents per Mcf with the current quarter actual adjustment yields a total actual adjustment of (1.71) cents per Mcf.

3. The combined effect of the above adjustments is Equitable's proposed gas cost recovery ("GCR") rate in the amount of \$3.7921 per Mcf, a decrease of 96.65 cents per Mcf from its last approved GCR rate. The decrease represents the combined effect of the supplier decrease and actual adjustments.

4. Equitable's adjustment in rates pursuant to the GCA provisions approved by the Commission in its Order in Case No. 89-286, dated June 27, 1990, is fair, just, and reasonable, in the public interest, and should be effective with final meter readings on and after May 1, 1991.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with final meter readings on and after May 1, 1991.


2. The GCR rate shall be \$3.7921 per Mcf effective with final meter readings on and after May 1, 1991.


3. Within 30 days of the date of this Order, Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.

4. Equitable shall include in each future filing a copy of its supplier's tariff sheet to support its EGC.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 89-286-D DATED 5/01/91

The following rates and charges are prescribed for the customers served by Equitable Gas Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.

RATES: Monthly

First	2 Mcf	\$4.4574 per Mcf
Next	18 Mcf	4.2574 per Mcf
Next	30 Mcf	4.1674 per Mcf
Next	50 Mcf	4.0874 per Mcf
All Over	100 Mcf	4.0174 per Mcf

The minimum bill shall be \$4.00.

The above rates include recovery of a Kentucky West Virginia Gas Company surcharge of 61.4 cents per Dth pursuant to the settlement of Docket No. TQ89-1-46, et. al. before the Federal Energy Regulatory Commission.

The following adjustments will be made to the above rates:

A surcharge of \$0.2278 per Mcf to reconcile undercollections occurring from 4/1/83 to 6/30/87 will be added to the above rates to be effective for 60 months beginning with the date of the Commission Order in Case No. 6602-GG or until the undercollection is recovered.

A refund of \$0.0897 per Mcf shall be applied to the retail service rates until such time as all refund obligations are discharged pursuant to PSC Order Nos. 6602-NN and 6602-TT.

The base rate for the future application of the purchased gas adjustment clause of Equitable Gas Company shall be:
