#### ORDER

On June 27, 1990, the Commission issued its Order in Case No. 89-286 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On October 2, 1991, Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), filed its quarterly GCA, which is to become effective November 1, 1991 and is to remain in effect until January 31, 1992.

On October 4, 1991, Equitable revised its quarterly GCA filing to reflect the most current filed rate of its supplier, Kentucky West Virginia Gas Company.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice of October 2, 1991, revised on October 4, 1991, set out certain revisions in rates which Equitable proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale increase in gas costs from its supplier in the amount of 70.56 cents per Mcf. Equitable's expected gas cost ("EGC") for the quarter beginning November 1, 1991 is \$4.2237 per Mcf, which includes a surcharge component of 80.54 cents per Mcf relating to the settlement of Kentucky West Virginia Gas Company Docket No. TQ 89-1-46-000, et. al. before the Federal Energy Regulatory Commission.

2. Equitable's notice set out a current quarter actual adjustment in the amount of (4.24) cents per Mcf to compensate for over-recovery of gas cost by the company through the operation of its gas cost recovery procedure during the months of May, June, and July 1991. Equitable's total actual adjustment is (24.73) cents per Mcf, which is composed of the current over-recovery plus remaining over- and under-recoveries from previous quarters.

3. The combined effect of the above adjustments is Equitable's proposed gas cost recovery ("GCR") rate in the amount of \$3.9764 per Mcf, an increase of 71.71 cents per Mcf from its last approved GCR rate. The increase represents the combined effect of the supplier increase and actual adjustments.

4. Equitable requested a waiver of the 30-day filing requirement. Pursuant to KRS 278.180, upon Equitable's showing of good cause, Equitable's request should be granted. The effective date for Equitable's increase should be on and after November 1, 1991.

5. Equitable's revised adjustment in rates pursuant to the GCA provisions approved by the Commission in its Order in Case No. 89-286, dated June 27, 1990, is fair, just, and reasonable, in the public interest, and should be effective with final meter readings on and after November 1, 1991.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 89-286-F DATED 10/31/91

The following rates and charges are prescribed for the customers served by Equitable Gas Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.

RATES: Monthly

Next	18	Mcf	4.4417 pe	er Mcf
Next	30	Mcf	4.3517 pe	er Mcf
Next	50	Mcf	4.2717 pe	er Mcf

The minimum bill shall be \$4.00.

The above rates include recovery of a Kentucky West Virginia Gas Company surcharge of 61.4 cents per Dth pursuant to the settlement of Docket No. TQ89-1-46, et. al. before the Federal Energy Regulatory Commission.

The following adjustments will be made to the above rates:

A surcharge of 0.2278 per Mcf to reconcile undercollections occurring from 4/1/83 to 6/30/87 will be added to the above rates to be effective for 60 months beginning with the date of the Commission Order in Case No. 6602-GG or until the undercollection is recovered.

The base rate for the future application of the purchased gas adjustment clause of Equitable Gas Company shall be:

Kentucky West Virginia Gas Company \$2.7046/Dth\*

\*Includes \$0.0146 Gas Research Institute Funding Charge and an Annual Charge Adjustment of \$0.0024.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with final meter readings on and after November 1, 1991.

2. The GCR rate shall be \$3.9764 per Mcf effective with final meter readings on and after the date of this Order.

3. Within 30 days of the date of this Order, Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.
