O R D E R

On October 8, 1990, the Commission issued its Order in Case No. 90-200 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of propane is increased or decreased or a refund is received.

On April 11, 1991, Columbia Gas of Kentucky, Inc. ("Columbia") notified the Commission that its cost of propane had decreased and submitted with its notice certain information in compliance with its propane cost adjustment clause on file with this Commission. On April 22, 1991, Columbia revised its filing to delete an unnecessary temperature compensation.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Columbia's notice of April 11, 1991, as amended April 22, 1991, set out certain revisions in rates which Columbia proposed to place into effect with propane supplied on and after May 13, 1991, said rates being designed to pass on the decrease in propane cost in the amount of \$6,198 or \$2.9213 per Mcf.

2. Columbia's adjustment in rates under the propane cost adjustment provisions approved by the Commission in its Order in Case No. 90-200 dated October 8, 1990 is fair, just, and reasonable, in the public interest, and should be effective with propane supplied on and after May 13, 1991.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable, and are approved effective with propane supplied on and after May 13, 1991.

2. Within 30 days of the date of this Order, Columbia shall file with this Commission its revised tariffs setting out the rates authorized herein.
