## ORDER

September 6, 1990, Blue Grass Rural Electric Cooperative On Corporation ("Blue Grass") filed its notice with the Commission proposing to revise its street and security lighting tariffs effective October 6, 1990. The proposed revision would cancel the watt high pressure sodium (ornamental) security light and the 100 175 watt mercury vapor, 400 watt mercury vapor and 100 watt high pressure sodium street lights which currently have no customers. Blue Grass additionally proposed replacement of security lights as follows: 175 watt mercury vapor replaced by 100 watt high pressure sodium and 400 watt mercury vapor replaced by 250 watt high pressure sodium. Both of these replacements would provide the same or more lighting effect at the rates now being charged. Since the proposed tariff totally eliminates certain security and street lights as noted above, it appears that Blue Grass intends to immediately replace its existing stock of these lights. However, if Blue Grass actually intends to replace these lights over time, its tariff should be revised to provide that those lights existing on the date of this Order will continue in service until replaced. The Commission finds that the street and security lighting changes proposed by Blue Grass are revenue neutral and should be approved.

The second part of Blue Grass's tariff filing is a proposal implement a levelized budget billing system in lieu of its to present budget billing tariff. The budget amount would be recomputed each month based on a 12-month history of the account. This would eliminate over-billing and under-billing during the year and no catch-up month would be required. Commission Regulation 807 KAR 5:006 requires utilities to offer a budget payment plan in their tariff "whereby a customer may elect to pay a fixed amount each month on a yearly basis in lieu of monthly billings based on actual usage." Blue Grass's proposed budget billing does not comply with this regulation in that the customer would not be paying a fixed amount each month. While the regulation provides for changes in the billed amount for significant reasons, the customer should not be subject to monthly billing changes as proposed.

IT IS THEREFORE ORDERED that:

1. The revision to street and security lighting tariffs as set out in Appendix A, attached hereto and incorporated herein, be and it hereby is authorized effective on and after the date of this Order.

2. The proposal to implement a levelized budget billing tariff be and it hereby is denied.

3. Within 30 days of the date of this Order, Blue Grass shall file with this Commission its revised tariffs setting out the rates authorized herein.
