ORDER

On December 11, 1990, Beaver-Elkhorn Water District ("Beaver-Elkhorn") filed an application to increase its charges for 3/4 inch and 5/8 inch service connections, reconnection of service, meter reading recheck and to establish a charge for the inspection of service lines.

Beaver-Elkhorn has met the requirements pursuant to 807 KAR 5:011, Section 10, regarding increases in non-recurring charges. Beaver-Elkhorn has filed a schedule which itemizes the expenses involved in providing reconnection of service and meter reading recheck. A review of the schedule indicates that the reconnection charge and meter reading recheck charge are equal to the expense of the charges, are fair, just, and reasonable, and should be approved.

A review of the schedules used for cost justification of the 5/8 inch and 3/4 inch service connection indicates that the charges are not equal to the expense of each charge. Beaver-Elkhorn's service connection fees for 5/8 inch meter and 3/4 inch meter include service pipe expense and installation expense that are not properly averaged. Therefore, the overhead expense is calculated from a wrong base number. The Commission has adjusted those schedules to properly reflect the correct overhead expense. Based on these adjustments, the charges for 5/8 inch and 3/4 inch service connections as set out in Appendix A, attached hereto and incorporated herein, are equal to the expense of each charge, are fair, just, and reasonable, and should be approved.

Beaver-Elkhorn also filed a schedule which itemizes the expenses involved in establishing a service line inspection charge. A review of this schedule indicates that the proposed charge is equal to the expense of the charge, is fair, just, and reasonable, and that the service line inspection charge should be approved.

The Commission, having considered the evidence and being sufficiently advised, HEREBY ORDERS that:

 The service connection fees for 5/8 inch meters and 3/4 inch meters proposed by Beaver-Elkhorn in its application are hereby denied.

2. Beaver-Elkhorn is hereby granted an increase in its reconnection charge, meter reading recheck charge, service connection charge for a 5/8 inch meter, and 3/4 inch meter as set out in Appendix A.

3. Beaver-Elkhorn is hereby permitted to establish a service line inspection charge as set out in Appendix A.

4. Within 30 days from the date of this Order, Beaver-Elkhorn shall file a revised tariff, signed by the appropriate utility officer, setting out the rates approved herein with the effective date being the date of this Order.
