O R D E R

On January 11, 1991, North Nelson Water District ("North Nelson") filed its revised tariff with the Public Service Commission ("Commission"), for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds:

1. North Nelson's supplier, City of Bardstown, will increase its rate for wholesale water from \$.80 to \$1.05 per 1,000 gallons effective with the February 1, 1991 billing.

2. North Nelson proposes to increase the rates to its customers, effective February 1, 1991.

3. During the 12 months ending October 31, 1990, North Nelson purchased 154,348,000 gallons of water and sold 138,667,500 gallons.

4. North Nelson's calculations are correct and show an increase in purchased water costs of \$38,587, resulting in a purchased water adjustment of 28 cents per 1,000 gallons.

5. The rates proposed by North Nelson and shown in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

6. The tariff sheets filed by North Nelson are correct and should be approved as filed.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment in the amount of 28 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after February 1, 1991.


2. The tariff sheets filed by North Nelson are hereby approved.


3. Within 20 days of the date rates approved herein are placed into effect, North Nelson shall file a copy of the notice to its customers and verification that such notice has been given.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 91-009 DATED 1/31/91

The following rates and charges are prescribed for the customers in the area served by North Nelson Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

<u>Usage Blocks</u>	<u>Monthly Rates</u>
First 2,000 gallons	\$8.06 Minimum Bill
Next 3,000 gallons	2.18 per 1,000 gallons
Next 5,000 gallons	1.88 per 1,000 gallons
Over 10,000 gallons	1.68 per 1,000 gallons
Truck Loading Rate	\$4.30 per 1,000 gallons
