O R D E R

The Commission, on its own motion, establishes this case for the purposes of filing all required Jurisdictional Usage Reports in one case file. To date, the Commission has required Jurisdictional Usage Reports to be filed in the cases listed in the Appendix attached to this Order.

The Jurisdictional Usage Reports will be more useful to the Commission if they are filed in one case filing. Most, if not all, of the utilities that have filed these reports have requested, and have been granted, confidential protection pursuant to 807 KAR 5:001, Section 7. Therefore, the Commission finds that disclosure of these reports is likely to cause the respective utility competitive injury and the reports are entitled to confidential protection on a continuing basis unless, or until, the Commission should order differently.

IT IS THEREFORE ORDERED that:

1. All utilities required by Order of the Commission to file Jurisdictional Usage Reports shall do so under the above-mentioned case style and number.


2. All previously filed Jurisdictional Usage Reports in the Commission's possession will be filed by the Commission in the above-mentioned case file.
