ORDER

Boone County Water and Sewer District, the city of Taylor Mill Utilities Commission, and the cities of Covington, Florence, and Fort Wright ("Intervenors") have moved for an extension of time in which to submit their first informational request to Kenton County Water District No. 1 ("Kenton District") and for modification of the procedural schedule. Kenton District has submitted a response in opposition. Having reviewed these motions and Kenton District's response, the Commission finds that the Intervenors should be granted an additional 20 days in which to submit their first informational request and that the present procedural schedule should be modified.

IT IS THEREFORE ORDERED that:

1. Intervenors' motion is granted.

2. Intervenors shall have 20 additional days to submit their first informational request to Kenton District.

3. Kenton District shall mail or deliver responses to those to informational requests already received no later than May 28, 1991.

4. The procedural schedule appended hereto is substituted for the procedural schedule set forth in the Commission's Order of April 19, 1991.

5. All other provisions of the Commission's Order of April 19, 1991 shall remain in effect.
