#### ORDER

On February 19, 1991, Goshen Utilities, Inc. ("Goshen") filed application requesting that it be allowed to increase its an existing connection fees for a  $5/8 \times 3/4$  inch meter and a 1 inch Goshen also proposed to increase its reconnection fee, meter. returned check charge, collection run charge, connection charge to new customers, meter recheck charge and customer requested meter On February 28, 1991, the Commission requested, by test charge. additional information curing certain filing that letter, deficiencies be filed within 15 days. On March 18, 1991, Goshen requested an extension through the close of business April 5, On April 8, 1991, Goshen cured all deficiencies thereby 1991. fulfilling the minimum filing requirements.

Goshen has filed schedules with the Commission which itemize the expenses involved in providing the above-mentioned services. After a review of these schedules and other matters of record and being otherwise sufficiently advised, the Commission finds that the proposed charges are equal to the expense of each charge and that the individual expenses are reasonable. Using information obtained from Goshen's 1990 Annual Report, the Commission finds that the proposed charges do not result in an operating ratio greater than that approved by this Commission in Goshen's last water rate case, Case No. 7797<sup>1</sup> and should therefore be approved.

IT IS THEREFORE ORDERED that:

1. Goshen is hereby granted an increase in its tap fees for a  $5/8 \times 3/4$  inch meter and a 1 inch meter to the charges set out in Appendix A, attached hereto and incorporated herein.

2. The non-recurring charges proposed by Goshen and shown in Appendix A are approved for services rendered on and after the date of this Order.

3. Within 30 days from the date of this Order, Goshen shall file its revised tariff sheets setting out the rates approved herein with the effective date being the date of this Order.
