O R D E R

On December 19, 1990, South Central Bell Telephone Company ("South Central Bell") filed with the Commission a proposed tariff for network services which are to be offered as part of the Open Network Architecture process.

On January 17, 1991, AT&T Communications of the South Central States, Inc. ("AT&T") filed a motion to intervene, but subsequently has filed a motion to withdraw its request to intervene.

After reviewing the proposed tariff, the Commission finds that additional investigation will be necessary for the new rate element Exchange Access Premium Charge. Accordingly, all portions of the filing associated with this element must be suspended.

Further, the Commission finds that the network services which are to be offered on an unbundled basis should be approved on an interim basis subject to further investigation by this Commission. These services are:

- Trunk Side Access Facility
- Uniform Access Number
- Custom Service Area
- Automatic Number Identification
- Call Detail Information

IT IS HEREBY ORDERED that:

1. South Central Bell's tariff for Exchange Access Premium Charge be and it hereby is suspended for 5 months from the proposed effective date up to and including August 5, 1991.

2. All sections of the December 19, 1990 tariff filing not referring to the Exchange Access Premium Charge are hereby approved on an interim basis pending further investigation of the Commission.


4. AT&T's motion to withdraw its request to intervene is hereby granted.

5. Nothing in this Order shall prevent the Commission from entering a final decision in this case prior to the termination of the suspension period.


6. Within 30 days of the date of this Order, South Central Bell shall file tariff sheets reflecting the Commission's decision herein.
