O R D E R

On March 21, 1991, West Oldham Utilities ("West Oldham") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:067. On March 28, 1991, the Commission notified West Oldham by letter of a deficiency in its application. The filing deficiency was cured by West Oldham on April 15, 1991.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds:

1. West Oldham purchases its water from Louisville Water Company ("Louisville"). Effective January 1, 1991, Louisville increased its rates for water sold to West Oldham from \$1.02 per 1,000 gallons to \$1.06 per 1,000 gallons. There was an increase in the \$245.70 service charge to \$255.06. However, there was no increase in the elevated service area surcharge of \$.19 per 1,000 gallons.

2. West Oldham did not specify a date for implementing the increased rates to its customers.

3. During the 12 months ending December 31, 1990, West Oldham purchased 54,259,000 gallons of water and sold 51,901,000 gallons.

4. The increase in West Oldham's purchased water costs is \$2,227, resulting in a purchased water adjustment of 4 cents per 1,000 gallons of water.

5. The purchased water adjustment of 4 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

6. The tariff sheet filed by West Oldham is correct and should be approved as filed.

IT IS THEREFORE ORDERED that:


1. The tariff sheet filed by West Oldham is hereby approved.


2. The purchased water adjustment of 4 cents per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after the date of this Order.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 91-089 DATED 4/24/91

The following rates and charges are prescribed for the customers in the area served by West Oldham Utilities. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Bi-Monthly Water Rates

5/8 x 3/4 Inch Meters

First 2,000 gallons	\$9.88 Minimum Bill
Over 2,000 gallons	2.36 per 1,000 gallons

1 Inch Meters

First 10,000 gallons	\$28.76 Minimum Bill
Over 10,000 gallons	2.36 per 1,000 gallons

1 1/2 Inch Meters

First 20,000 gallons	\$52.36 Minimum Bill
Over 20,000 gallons	2.36 per 1,000 gallons
