O R D E R

This matter arising upon the motion of Mr. and Mrs. Bradford Stewart ("the Stewarts"), filed May 23, 1991, for full intervention, and it appearing to the Commission that the Stewarts have a special interest which is not otherwise adequately represented, and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings, and this Commission being otherwise sufficiently advised,

IT IS ORDERED that:

1. The motion of the Stewarts to intervene is granted.
2. The Stewarts shall be entitled to the full rights of parties and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should the Stewarts file documents of any kind with the Commission in the course of these proceedings, they shall also serve a copy of said documents on all other parties of record.

2. Kentucky RSA #4 Cellular General Partnership shall appear at the hearing and present testimony on the engineering design, location, and construction of the cell site, and the health and safety issues relating to the operation of the cell site.

3. Any interested person shall have the opportunity to present testimony or comment on any aspect of the proposed cell site, including local issues such as impact on property values.
