
O R D E R

The formal complaint filed in this matter requests the Commission to order the named defendant to assist the complainant "in the vigorous prosecution (including the removal of telephone service from those who have been repeating offenders) of the persons involved in this conspiracy to harass and persecute the complainant." (A copy of the complaint is attached hereto and marked Exhibit A.) KRS 278.260 only gives the Commission jurisdiction over complaints as to rates or service of any utility. Accordingly, the Commission lacks jurisdiction to decide the matter complained of or to give the relief sought.


IT IS THEREFORE ORDERED that this complaint is dismissed with prejudice.

Before the Public Service Commission, Winston R. Hardy of 239 Hoot Owl Camp Road, Shepherdsville, Kentucky 40165 is making a formal complaint against Mr. J. Teensma of Alltel Kentucky, Inc., P. O. Box 68, Shepherdsville, Kentucky 40165.


The complainant states that J. Teensma has and is refusing to assist and/or cooperate with obtaining information and the prosecution of the persons involved in making harrassing phone calls to the complainant. These phone calls are of an abhorrent, consistently threatening and/or obscene and mischievous nature, occurring at all hours of the day and night for a period of fifteen (15) years... numbering into the tens of thousands... with approximately 800 calls verified through various phone traps over a two year period.

The complainant is aware that Mr. Teensma feels he has made a reasonable and prudent economic decision...but Senior Executive, Joe Maxey, at the Alltel home office, in Arkansas, told the complainant that in his twenty-eight years of experience in the telephone business he has never heard of such an intense and sustained harrassment.

Therefore, Winston R. Hardy does beg of the commission that the defendant, J. Teensma, be ordered to fully and completely assist and cooperate with the complainant in obtaining the required information and assist in the vigorous prosecution (including the removal of telephone service from those who have been repeating offenders) of the persons involved in this conspiracy to harrass and persecute the complainant.
