ORDER

On May 8, 1991, Dexter-Almo Heights Water District ("District") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure, KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. The District's supplier, Murray Water and Wastewater System ("Murray"), increased its rate for water sold to the District from \$.85 to \$1.25 per 1,000 gallons, effective with the billing payable May 1, 1991.
- 2. The District increased the rates to its customers effective May 1, 1991.
- 3. During the 12 months ending February 28, 1991, the District purchased 29,295,000 gallons of water and sold 22,408,200 gallons.
- 4. The calculations made by the District are correct and show an increase in purchased water costs of \$11,718, resulting in a purchased water adjustment of 52 cents per 1,000 gallons.

- 5. The purchased water adjustment of 52 cents per 1,000 gallons and the rates shown in Appendix A, attached hereto and incorporated herein, are fair, just and reasonable and should be approved.
- 6. The tariff sheet filed by the District with its application should be denied as it does not conform with the requirements of 807 KAR 5:011, Section 4(1), (2), (4)(a)(b).

IT IS THEREFORE ORDERED that:

- 1. The tariff sheet filed by the District is hereby denied.
- 2. The purchased water adjustment of 52 cents per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after May 1, 1991.
- 3. Within 30 days of the date of this Order, the District shall file a revised tariff, signed by the appropriate utility officer, setting out the rates approved herein.
- 4. Within 20 days of the date of this Order, the District shall file a copy of the notice to its customers and verification that such notice has been given.
