## ORDER

On August 26, 1991, Elkhorn Water District ("Elkhorn") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure, KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. Elkhorn's supplier, Frankfort Electric and Water Plant Board ("Frankfort"), increased its rates for wholesale water from \$.90 to \$.98 per 1,000 gallons effective with the water bill due October 15, 1991 for services rendered from August 20, 1991 through September 20, 1991. Based on 5,000 gallons average monthly usage, the average monthly bill for an Elkhorn customer will increase from \$15.75 to \$16.20 which is an increase of 2.86 percent.
- 2. Elkhorn increased the rate to its customers effective August 20, 1991.
- 3. During the 12 months ending July 31, 1991, Elkhorn purchased 42,236,200 gallons of water and sold 38,799,000 gallons.

- 4. The increase in purchased water costs is \$3,379, resulting in purchased water adjustment of 9 cents per 1,000 qallons of water.
- 5. The purchased water adjustment of 9 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.
- 6. The tariff sheet filed by Elkhorn is correct and should be approved as filed.

### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of 9 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after August 20, 1991.
  - 2. The tariff sheet filed by Elkhorn is approved as filed.
- 3. Within 20 days of the date of this Order, Elkhorn shall file verification that notice has been given to its customers.
