O R D E R

IT IS ORDERED that Business Choice Network, Inc. ("BCN") shall file the original and ten copies of the following information with the Commission. The information requested shall be placed in a bound volume with each item tabbed.

The information requested herein is due no later than 30 days from the date of this Order. If the information cannot be provided by this date, BCN shall submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it can be furnished. Such motion will be considered by the Commission.

1. Has BCN or any of its affiliates ever provided and/or collected any money from the public for the provision of intrastate telecommunications services in Kentucky? If so, explain in detail.

2. Clarify whether or not BCN is seeking intraLATA operating authority.

3. State whether BCN shall comply with the Commission's rules, restrictions, and prohibition against providing intraLATA services by non-local exchange facilities-based carriers (Administrative Case No. 323).¹ Explain in detail.

4. Does BCN own and/or operate any transmission facilities in any jurisdiction? If so, explain.

5. Does BCN have any affiliation with any other company which owns and/or operates any transmission facilities in any jurisdiction? If so, explain.

6. Provide a toll-free number or provision for accepting collect calls for customer complaints.

7. Refer to Original Page 10, Section 2.3.2. This section indicates BCN plans to offer operator-assisted services. Provide appropriate tariff sheets setting out the requirements for operator-assisted services delineated in the Commission's March 27, 1991 Order in Administrative Case No. 330.²

8. Refer to Original Page 14, Section 2.4.6. Provide a revised tariff sheet clarifying that the customer is liable for such damages as may be determined by a court having jurisdiction over the parties.

9. Refer to Original Page 15, Section 2.5. Provide a revised tariff sheet to include the notice requirements prescribed by 807 KAR 5:006, Section 11, for refusal or termination of service.


10. Refer to Original Page 18, Section 2.9. Provide a revised tariff sheet clarifying that the late payment penalty will be assessed only once on each delinquent monthly bill for service and that the penalty will not be applied to unpaid penalties.

11. Refer to Original Pages 24 and 25. What rates will be charged for calls where distance exceeds 430 miles? Provide revised tariff sheets.

12. Provide rate schedules for operator-assisted calls.
