O R D E R

On December 7, 1990, the Commission issued its Order in Case No. 90-076 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On April 1, 1992, Elzie Neeley Gas Company, Inc. ("Elzie Neeley") filed its quarterly GCA, which is to become effective May 1, 1992 and is to remain in effect until July 31, 1992.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Elzie Neeley's notice of April 1, 1992 set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale change in gas cost from its supplier. Elzie Neeley's expected gas cost ("EGC") adjustment for the quarter beginning May 1, 1992 should be \$3.6461 per Mcf.

2. Elzie Neeley's notice included an actual adjustment in the amount of 9.76 cents per Mcf to collect under-recoveries experienced by Elzie Neeley through the operation of its gas cost recovery procedure during the months of October 1991 through January 1992.

3. Elzie Neeley's notice included a refund adjustment in the amount of 9.23 cents per Mcf to refund over-collections to its customers pursuant to the Order in Case No. 90-076-C.<sup>1</sup>

4. The combined effect of the above adjustments is Elzie Neeley's gas cost recovery rate ("GCR") in the amount of \$3.6514 per Mcf, a decrease of 23.34 cents per Mcf from its last approved rates.

5. The rates set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 90-076 dated December 7, 1990, are fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after May 1, 1992.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with gas supplied on and after May 1, 1992.

3. Within 30 days of the date of this Order, Elzie Neeley shall file with this Commission its revised tariffs setting out the rates authorized herein.


