O R D E R

On December 7, 1990, the Commission issued its Order in Case No. 90-076 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On September 30, 1992, Elzie Neeley Gas Company, Inc. ("Elzie Neeley") filed its quarterly GCA, which is to become effective November 1, 1992 and is to remain in effect until January 31, 1993.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Elzie Neeley's notice of September 30, 1992 set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale change in gas cost from its supplier.

2. Elzie Neeley's expected gas cost ("EGC") adjustment for the quarter beginning November 1, 1992 should be \$3.8551 per Mcf.

3. Elzie Neeley's notice included a current quarter actual adjustment in the amount of (5.26) cents per Mcf to return over-recoveries to its customers resulting from the operation of its GCA

during the months of May, June, and July. Elzie Neeley's total actual adjustment in the amount of (0.74) cents per Mcf is calculated to return the current over-recovery, as well as over and under-recoveries from previous quarters.

4. Elzie Neeley's notice included a refund adjustment in the amount of 6.21 cents per Mcf from a previous quarter. There were no current quarter refund adjustments.

5. The combined effect of the above adjustments is Elzie Neeley's gas cost recovery rate ("GCR") in the amount of \$3.7856 per Mcf, a decrease of 3.33 cents per Mcf from its last approved rates.

6. The rates set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 90-076 dated December 7, 1990, are fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after November 1, 1992.


IT IS THEREFORE ORDERED that:


2. Within 30 days of the date of this Order, Elzie Neeley shall file with this Commission its revised tariffs setting out the rates authorized herein.
