O R D E R

On December 7, 1990, the Commission issued its Order in Case No. 90-077 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On December 24, 1991, Mike Little Gas Company, Inc. (Mike Little") filed its quarterly GCA, which is to become effective February 1, 1992 and is to remain in effect until April 30, 1992.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Mike Little's notice of December 24, 1991 set out certain revisions in rates which Mike Little proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale change in gas cost from its supplier. Mike Little did not use the most currently available supplier rate in its calculation; hence, its proposed rates should be denied.

2. Mike Little's expected gas cost ("EGC") adjustment for the quarter beginning February 1, 1992 should be \$2.9012 per Mcf based on its supplier rate effective October 1, 1991.

3. Mike Little's notice included no actual adjustment. This adjustment will be unavailable to Mike Little until its GCA clause has been in effect two quarters.

4. The combined effect of the above adjustments is Mike Little's gas cost recovery rate ("GCR") in the amount of \$2.9012 per Mcf, a decrease of 4.62 cents per Mcf from its last approved rates.

5. The rates set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 90-077 dated December 7, 1990, are fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after February 1, 1992.

IT IS THEREFORE ORDERED that:


1. The rates proposed by Mike Little be and they hereby are denied.

2. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with gas supplied on and after February 1, 1992.


3. Within 30 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 90-077-C DATED 1/31/92

The following rates and charges are prescribed for the customers in the area served by Mike Little Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

RATES: Monthly

First 1 Mcf - Minimum Bill	\$5.7223 Per Mcf
All Over 1 Mcf	\$5.5052 Per Mcf

The base rate for the future application of the purchased gas adjustment clause of Mike Little Gas Company, Inc. shall be:
