O R D E R

On January 13, 1992, the Commission issued its Order in Case No. 91-127 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On December 1, 1992, B & H Gas Company, Inc. ("B & H") filed its quarterly gas cost adjustment ("GCA"), which is to become effective January 1, 1993 and remain in effect until April 1, 1993.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. B & H's notice of December 1, 1992 set out certain revisions in rates which B & H proposed to place into effect, said rates being designed to pass on to its customers its wholesale gas cost from its suppliers. B & H's expected gas cost ("EGC") for the quarter beginning December 1, 1992 is \$3.7426 per Mcf.

2. B & H's notice set out no refund adjustment.

3. B & H's notice set out a current quarter actual adjustment in the amount of (3.76) cents per Mcf to compensate for overrecovery of gas cost by the company through the operation of

its gas cost recovery procedure during the months of July, August, and September 1992. B & H did not use the EGC in effect during those months in calculating its overrecovery; the current quarter actual adjustment should be (.06) cents per Mcf. B & H neglected to include previous quarter adjustments in its total adjustment. The correct total adjustment of 1.81 cents per Mcf is designed to correct the current over-collection as well as under- or over-collections from previous quarters.

4. B & H's notice set out no balance adjustment. This adjustment will be unavailable to B & H until the approved actual adjustment has been in effect for 4 quarters.

5. The combined effect of the above adjustments is B & H's corrected gas cost recovery rate ("GCR") in the amount of \$3.7607 per Mcf, which is a decrease of .86 cents per Mcf from its last approved rates.

6. B & H's adjustment in rates, set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 91-127 dated January 13, 1992, is fair, just, and reasonable, in the public interest, and should be effective with service rendered on and after January 1, 1993.


IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with service rendered on and after January 1, 1993.


2. Within 30 days of the date of this Order, B & H shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 91-127-D DATED December 15, 1992.

The following rates and charges are prescribed for the customers served by B & H Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.

A surcharge in the amount of 3 cents per Mcf shall be added to the above rates until the obligation owed Kentucky West Virginia Gas Company has been discharged or is recalculated.
