ORDER

On November 1, 1991, BSN Telecom Company ("BSN") filed its application with the Commission seeking a Certificate of Public Convenience and Necessity to provide intrastate, interLATA telecommunications services as a reseller within the Commonwealth of Kentucky.

BSN proposes to resell AT&T Communications tariffed services on an interLATA basis to small and medium-sized businesses within the Commonwealth of Kentucky in accordance with the terms and conditions set forth in its tariff. BSN is not seeking authority to provide any operator-assisted telecommunications services or any service to payphones.

BSN employs no transmission or reception telecommunications equipment or facilities in the performance of its services. All operating facilities, equipment and networking will continue to be provided by the underlying carrier. However, BSN shall sell and provide order processing and billing for its customers. The

financial, managerial, and technical capabilities of BSN are demonstrated in the application provided by BSN. The rates proposed by BSN should be approved as the fair, just and reasonable rates to be charged.

The Commission, having considered the application and the information provided by BSN, and being otherwise sufficiently advised, HEREBY ORDERS that:

- 1. BSN be and it hereby is granted authority to provide intrastate, interLATA telecommunications services within the Commonwealth of Kentucky on and after the date of this Order.
- 2. BSN shall comply with the provisions of the May 25, 1984 and October 26, 1984 Orders in Administrative Cases No. 273.
- 3. BSN's authority to provide service in this Commonwealth is strictly limited to those services described in this Order and BSN's application.
- 4. BSN shall fully comply with the Commission's prohibition against offering intraLATA services.
- 5. BSN is not authorized to provide any operator assisted telecommunications services.
- 6. Within 30 days from the date of this Order, BSN shall file with the Commission copies of all advertising to be used in marketing its rates and services in Kentucky.
 - 7. The rates proposed by BSN are hereby approved.

- 8. Within 30 days from the date of this Order, BSN shall file its tariff sheets pursuant to 807 KAR 5:011, setting out the rates approved herein and rules governing the provision of service in accordance with the Commission's Orders and administrative regulations.
- 9. All rates and services advertised by BSN shall comply with KRS 278.170(1).
- 10. Within 30 days from the date of this Order, BSN shall file its tariff sheets in accordance with 807 KAR 5:011 to conform to the restrictions and conditions of service contained herein.
