ORDER

IT IS HEREBY ORDERED that First Kentucky Cellular Corporation ("First Kentucky") shall:

1. Respond in writing to Mr. Faulkner's concerns regarding the alleged hazard that exists due to the proposed tower's close

Case No. 91-247, The Application of First Kentucky Cellular Corp., a Delaware Corporation d/b/a Cellular Telephone Company of Kentucky, for the Issuance of a Certificate of Public Convenience and Necessity to Provide Domestic Public Cellular Radio Telecommunications Service to the Public in the Kentucky Rural Service Area which Includes Bell, Clay, Harlan, Knox, Leslie and Whitley Counties in Kentucky, and for the Establishment of Initial Rates.

proximity to high voltage electric transmission lines, with a copy to the Commission.

2. Respond to the Commission with documentation from Kentucky Utilities Company regarding whether or not the proposed construction of the tower will create a potential hazard, and whether any precautions should be taken during the construction to avoid contact with the high voltage electric transmission lines.

Gentlemen:

My Comments and objections to the proposed construction noted in Case No. 91-247 are as follows:

- 1. The proposed location of this tower is in the center hub of a shopping center, a drive-in restaurant and a housing subdivision. This leads me to believe that surrounding property owners were of little concern to Kentucky Cellular Corporation when this site was selected.
- 2. The proposed tower (concrete base of which is already in place) will be constructed within Fifty (50) to Seventy (70) feet of two (2) homes and a High Voltage Electric Transmission Line (Kentycky Utilities Co.). Should this tower ever be toppled by winds, toranados or other means, catastrophic consequences could occur.
- 3. The proposed tower with attached guy wires, being within the near proximity of my home, will create an unsightly view and will definitely be determintal to the value of my property.
- 4. The proposed tower will most likely require permanent blinking lights to be installed on it. This will create a perpetual nuisance when viewing the area from my home. Also, the blinking lights would always show through my windows at night.
