ORDER

On June 15, 1992, Taylor County Rural Electric Cooperative Corporation ("Taylor County") filed a motion requesting the Commission extend to July 31, 1992, the time period for it to respond to the Commission's Order of June 5, 1992. Taylor County cited the number of inquiries made in the Order, the vacation schedules of its staff, the research and analysis required by the inquiries, and Taylor County's July 10, 1992 annual meeting as reasons the extension should be granted.

The Commission's May 22, 1992 Order establishing the procedural schedule for this case required the response to the June 5, 1992 Order to be filed by June 26, 1992. The Commission believes that Taylor County's request for an additional 5 weeks to respond to the June 5, 1992 Order is unreasonable. The reasons cited by Taylor County do not justify allowing it a total of 8 weeks to respond to the data request.

However, the Commission will allow Taylor County an additional 5 working days to respond to the June 5, 1992 Order. Allowing these additional days will require a modification of the procedural schedule previously established.

IT IS THEREFORE ORDERED that:

1. Taylor County's request to extend its response date for

the June 5, 1992 Order to July 31, 1992 is hereby denied.

2. The procedural schedule established in the Commission's

Order of May 22, 1992 is hereby amended to allow Taylor County 5

additional business days to respond to the June 5, 1992 Order and

to make other modifications necessitated by the additional response

time granted.

3. The amended procedural schedule listed in Appendix A,

attached hereto and incorporated herein, shall be followed.

4. All other provisions of the Commission's Order of May 22,

1992 shall remain in full force and effect.
