O R D E R

On March 5, 1992, Hima-Sibert Water District ("Hima-Sibert") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068. On March 12, 1992, the Commission requested that additional information be filed. The requested information was filed on March 25, 1992, and the record is now complete.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. Hima-Sibert's supplier, city of Manchester, increased its rate for wholesale water from \$1.25 to \$1.50 per 1,000 gallons, effective May 21, 1990.

2. Hima-Sibert proposed to increase the rates to its customers, effective March 20, 1992. Based on average usage of 5,000 gallons, the monthly bill for Hima-Sibert's customers would increase by \$1.40 from \$19.55 to \$20.95, an increase of 7.16 percent.

3. During the 12 months ending December 31, 1991, Hima-Sibert purchased 34,527,500 gallons of water and sold 30,314,000 gallons.

4. The increase in purchased water costs is \$8,632, resulting in a purchased water adjustment of 28 cents per 1,000 gallons.

5. The purchased water adjustment of 28 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

6. The proposed tariff filed by Hima-Sibert is correct and should be approved.

IT IS THEREFORE ORDERED:


1. The purchased water adjustment of 28 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after March 20, 1992.

2. The proposed tariff filed by Hima-Sibert is approved.


3. Within 30 days of the date of this Order, Hima-Sibert shall file a copy of the notice to its customers and verification that such notice has been given.
