O R D E R

On May 13, 1992, North Nelson Water District ("North Nelson") filed an application with the Commission wherein it proposed to adjust its rates for certain non-recurring charges effective June 15, 1992. By letter of May 5, 1992, North Nelson was informed of various deficiencies in its filing. On June 2, 1992, North Nelson was informed by letter that as a result of its May 13, 1992 response, its application met minimum filing requirements. On June 4, 1992, the proposed charges were suspended up to and including November 14, 1992.

North Nelson proposed to: (1) increase its bill collection fee from \$5 to \$10; (2) increase its reconnection fee as a result of nonpayment from \$20 to \$25; (3) increase its customer-requested meter rereading charge from \$8 to \$10 if the meter was found to have been read correctly; and (4) increase its customer-requested meter test from \$16 to \$20 if the meter test results show the meter is registering accurately. North Nelson also proposed to establish a \$10 charge to reconnect a meter that had been disconnected pursuant to a customer's request.

The Commission, having considered the evidence of record and being sufficiently advised, finds that the charges proposed by North Nelson are fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The charges in Appendix A, which is attached hereto and incorporated herein, are approved for services rendered by North Nelson on and after the date of this Order.


2. Within 30 days of the date of this Order, North Nelson shall file its revised tariff sheets setting forth the charges approved herein.
