O R D E R

On May 7, 1992, American Telephone Network, Inc. ("American Telephone") filed its application with the Commission seeking a Certificate of Public Convenience and Necessity to provide intrastate, long-distance telecommunications services as a reseller within the Commonwealth of Kentucky.

American Telephone is a Florida Corporation proposing to resell AT&T Communications of the South Central States, Inc.'s tariffed services to small and medium sized businesses within the Commonwealth of Kentucky in accordance with the terms and conditions set forth in its tariff. American Telephone is not seeking authority to provide any operator-assisted telecommunications services.

American Telephone does not own the transmission or reception telecommunications equipment or facilities necessary to resell telecommunications service. The equipment, networking and operating facilities will be provided by the underlying carrier. American Telephone will not construct any facilities in the Commonwealth of Kentucky.

In American Telephone's July 6, 1992 response to the Commission's June 5, 1992 Order, it informed the Commission that money had been collected for non-certified service. This violation was resolved in Case No. 92-306<sup>1</sup> by Commission Order dated August 26, 1992.

The application provided by American Telephone demonstrates its financial, managerial, and technical capability. The rates proposed should be approved as the fair, just and reasonable rates to be charged.

The Commission, having considered the application, the information provided by American Telephone, and being otherwise sufficiently advised, HEREBY ORDERS that:

1. American Telephone be and it hereby is granted authority to provide intrastate, long-distance telecommunications services as a reseller within the Commonwealth of Kentucky on and after the date of this Order.

2. American Telephone shall comply with the provisions of the Orders in Administrative Case No. 323.<sup>2</sup>

3. American Telephone's authority to provide service in this Commonwealth is strictly limited to those services described in this Order and American Telephone's application.



4. The rates and charges proposed by American Telephone are hereby approved, as filed on May 7, 1992.




