O R D E R

On June 16, 1992, North McLean Water District ("North McLean") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. North McLean purchases water from West Daviess Co. Water District ("West Daviess").

2. Effective June 16, 1992, West Daviess will increase its rate for wholesale water from \$.956 to \$1.31 per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to North McLean's customers will increase \$1.10 from \$17.40 to \$18.50, an increase of 6.32 percent.

3. North McLean proposed to increase the rates to its customers effective June 16, 1992.

4. During the 12 months ending May 12, 1992, North McLean purchased 81,987,800 gallons of water and sold 74,325,300 gallons.

5. North McLean's calculations are correct and show an increase in purchased water costs of \$16,487.37, resulting in a purchased water adjustment 22 cents per 1,000 gallons.

6. The purchased water adjustment of 22 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 22 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after June 16, 1992.

2. North McLean's proposed tariff is approved.


3. Within 30 days of the date of this Order, North McLean shall file verification that the notice to its customers has been given.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 92-253 DATED July 6, 1992

The following rates and charges are prescribed for the customers in the area served by North McLean Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

<u>Usage Levels</u>	<u>Monthly Rates</u>
First 2,000 gallons	\$9.46 Minimum Bill
Next 2,000 gallons	3.18 per 1,000 gallons
Next 2,000 gallons	2.68 per 1,000 gallons
Next 4,000 gallons	2.38 per 1,000 gallons
Next 30,000 gallons	2.08 per 1,000 gallons
Next 60,000 gallons	1.88 per 1,000 gallons
Over 100,000 gallons	1.68 per 1,000 gallons
