O R D E R

On July 13, 1992, Southern-Mason Water District ("Southern-Mason") filed an application for a Certificate of Public Convenience and Necessity to construct a waterworks improvement project, for approval of its plan of financing for this project, and for adjustments to its water service rates. The Commission granted Southern-Mason its Certificate and new rates for water usage blocks on August 10, 1992. The Commission was then advised by Southern-Mason on August 24, 1992 that a rate increase for field connections had been inadvertently excluded from its application.

Southern-Mason proposed to increase its field connection rate as follows:

Current Rates		Proposed Rates	
First 1,000 gallons	\$5.73	\$6.10	Minimum bill
Next 4,000 gallons	3.23	3.43	Per 1,000 gallons
Next 5,000 gallons	2.93	3.11	Per 1,000 gallons
Next 10,000 gallons	2.73	2.90	Per 1,000 gallons

The Commission, having considered the evidence of record and being sufficiently advised, finds that the charges proposed by Southern-Mason are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The tariff sheet filed by Southern-Mason on September 29, 1992 is hereby approved as filed.

2. The charges in Appendix A, which is attached hereto and incorporated herein, are approved for services rendered by Southern-Mason on and after the date of this Order.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 92-290 DATED October 15, 1992

The following rates and charges are prescribed for the customers in the area served by Southern-Mason Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Field Connection Rate

First	1,000 gallons	\$6.10 Minimum Bill
Next	4,000 gallons	3.43 per 1,000 gallons
Next	5,000 gallons	3.11 per 1,000 gallons
All over	10,000 gallons	2.90 per 1,000 gallons
