ORDER

On August 25, 1992, Alton Water and Sewer District ("Alton") filed an application with the Public Service Commission ("Commission") for the purpose of adjusting its rates for sewer service pursuant to KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds that:

 Alton's provider of sewer service, the city of Lawrenceburg, increased its charge for sewage treatment from \$1.25 to \$1.35 per 1,000 gallons effective October 8, 1991.

2. Alton's rate for sewer service is based on water purchased from its water supplier and water sold to its customers. During the 12 months ending July 31, 1992, Alton purchased 23,038,000 gallons of water and sold 20,412,120 gallons.

3. The increase in Alton's sewer service cost is \$2,303.80 resulting in a purchased sewer adjustment of 11 cents per 1,000 gallons. Based on an average monthly usage of 5,218 gallons, the monthly bills for Alton's customers will increase from \$22.70 to \$23.27, an increase of 2.5 percent.

4. The purchased sewer adjustment of 11 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased sewer adjustment of 11 cents per 1,000 gallons and the rates in Appendix A are hereby approved for service rendered on and after the date of this Order.

2. Within 30 days of the date of this Order, Alton shall file a revised tariff sheet setting out the rates approved herein.

3. Within 30 days of the date of this Order, Alton shall file a copy of the notice to its customers and verification that such notice has been given.
