ORDER

On November 30, 1992, Hardin County Water District No. 2 ("Hardin County No. 2") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 278.015.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. Hardin County No. 2 purchases water from Hardin County Water District No. 1 and the city of Elizabethtown.

2. Effective November 20, 1992, Hardin County No. 1 will increase its rate for wholesale water from \$.9475 to \$.9851 per 1,000 gallons. The city of Elizabethtown rate will not change and will remain at \$1.43. Based on an average monthly usage of 5,000 gallons, bills to Hardin County No. 2 customers will increase from \$24.01 to \$24.16, an increase of 0.6 percent.

3. Hardin County No. 2 proposed to increase the rates to its customers effective November 20, 1992.

4. During the 12 months ending October 31, 1992, Hardin County No. 2 purchased 404,355,185 gallons of water from Hardin County No. 1 and 4,140,000 gallons from the city of Elizabethtown for a total of 408,495,185 gallons purchased. During the same period of time, Hardin County No. 2 produced 303,046,900 gallons of water for a total of 711,542,085 gallons available for resale. Hardin County No. 2 sold 573,772,300 gallons of water during this same period.

5. Hardin County No. 2's calculations are correct and show an increase in purchased water costs of \$15,203.75, resulting in a purchased water adjustment of \$.03 per 1,000 gallons.

6. The purchased water adjustment of \$.03 per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$.03 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after November 20, 1992.

2. Hardin County No. 2's proposed tariff is approved.

3. Within 30 days of the date of this Order, Hardin County No. 2 shall file verification that the notice to its customers has been given.
