## ORDER

IT IS ORDERED that Boone County Water and Sewer District ("Boone District") shall file the original and 8 copies of the following information with the Commission within 20 days from the date of this Order, with a copy to all parties of record. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure its legibility.

- 1. State the date when construction of the proposed facilities began.
- Provide the minutes of each meeting of Boone District's Board of Commissioners since 1987 in which the proposed facilities were discussed.
- 3. Provide all correspondence between Boone District and Sanitation District No. 1 of Campbell and Kenton Counties

("Sanitation District No. 1") in which the proposed facilities were discussed.

- 4. State when the proposed facilities are expected to begin operation.
- 5. Provide a detailed depreciation schedule of the proposed facilities. List all major components separately.
- 6. a. List all of the proposed facilities (e.g., trunklines, pump stations, force mains) which Boone District will operate and maintain.
- b. List all of the proposed facilities (e.g., trunklines, pump stations, force mains) which Sanitation District No. 1 will operate and maintain.
- 7. a. State how Boone District intends to pay the proposed facilities' estimated \$8.5 million cost.
- b. State whether Boone District intends to adjust its rates to cover the cost of the proposed facilities.
- c. If yes, state when it intends to seek this rate adjustment and the expected amount.
- d. State whether existing customers will be charged a fee to connect to the proposed facilities.
  - e. If yes, state the expected amount of this fee.
- f. State the amount of any fee to be charged to new customers who connect to the proposed facility.
- 8. Provide a copy of the preliminary approval of the proposed facilities' plans and specifications issued by the

Division of Water, Kentucky Natural Resources and Environmental Protection Cabinet.

- 9. Provide a copy of the specifications upon which the proposed facilities were bid.
- 10. Provide a copy of the preliminary and final engineering reports for the proposed facilities.
- 11. Provide a copy of the bid tabulations and the final summation of the cost of construction for each of the proposed facilities.
- 12. Refer to Boone District's Application, Exhibit 5, and Boone District's Response to the Commission's Order of December 14, 1992, Item 6. In its Application, Boone District states that it "will operate and maintain the collection system." Explain how Boone District will perform these actions without incurring any operation or maintenance costs.
- 13. Provide a detailed cost estimate of each of the proposed facilities. Each estimate should include all capitalized costs (i.e., construction, engineering, legal, administrative).
