#### O\_R D\_E\_R

On October 2, 1990, the Commission issued its Order in Case No. 90-041 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On June 10, 1993, The Union Light, Heat and Power Company ("ULH&P") filed an interim GCA to be effective July 1, 1993 and which is to remain in effect until September 1, 1993. The purpose of this interim adjustment is to pass along supplier decreases which have occurred since ULH&P's last GCA filing.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. ULH&P's notice of June 10, 1993 set out certain revisions in rates which ULH&P proposed to place into effect, said rates being designed to pass on to its customers the wholesale decrease in gas costs from its suppliers in the amount of 23.5 cents per Mcf including take-or-pay billings. ULH&P's expected gas cost ("EGC") is \$3.890 per Mcf, which includes a take-or-pay recovery component of 0 cents per Mcf. 2. All of ULH&P's other adjustments remained the same as those in effect in its regular guarterly filing.

3. ULH&P's gas cost recovery rate is \$3.981 per Ncf, which is a decrease of 23.5 cents per Mcf from the previously authorized rate.

4. ULH&P's adjustment in rates contained in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 90-041 dated October 2, 1990, is fair, just, and reasonable, in the public interest, and should be effective with bills rendered on and after July 1, 1993.

5. The GCA adjustment, as reflected in the Appendix, was applied to base rates placed into effect by ULHSP on April 26, 1993 in Case No. 92-346.<sup>1</sup>

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are authorized to be effective with bills rendered on and after July 1, 1993.

2. Within 30 days of the date of this Order, ULH&P shall file with this Commission its revised tariffs setting out the rates authorized herein.
