ORDER

On December 7, 1990, the Commission issued its Order in Case No. 90-077 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On October 4, 1993, Mike Little Gas Company, Inc. ("Mike Little") filed its quarterly GCA, which is to become effective November 1, 1993 and is to remain in effect until January 31, 1994.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Mike Little's notice of October 4, 1993 set out certain revisions in rates which Mike Little proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale gas cost from its supplier. Mike Little's expected gas cost ("EGC") adjustment for the quarter beginning November 1, 1993 is \$4.0925 per Mcf.
 - Mike Little's notice set out no refund adjustment.
- 3. Mike Little's notice included a current quarter actual adjustment ("AA") in the amount of 6.21 cents per Mcf to compensate

for under-recoveries experienced by Nike Little through the operation of its gas cost recovery procedure during the months of May, June, and July 1993. Mike Little's total AA in the amount of 27.07 cents per Mcf is calculated to return the current under-recovery, as well as over- and under-recoveries from previous quarters.

- 4. The combined effect of the above adjustments is Nike Little's gas cost recovery rate ("GCR") in the amount of \$4.3632 per Mcf, an increase of 38.48 cents per Mcf from its last approved rates.
- 5. The rates set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 90-077 dated December 7, 1990, are fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after November 1, 1993.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable, and are approved effective with gas supplied on and after November 1, 1993.
- 2. Within 30 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.
