O R D E R

Boone County Water and Sewer District ("Boone District") has applied for Commission approval to adjust its rates for sewer service rendered on and after July 1, 1993. After reviewing the application, the Commission finds that further proceedings are necessary to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to July 1, 1993.

IT IS THEREFORE ORDERED that:

1. The rates proposed in Boone District's application are suspended for the period through and including November 30, 1993.
2. The procedural schedule set forth in Appendix A to this Order shall be followed.
3. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.
4. In lieu of submitting testimony in prepared verified form, Commission Staff may submit a written report on Boone District's application.

5. Boone District shall, upon written request, make its books, accounts, papers, and records available to Commission Staff for inspection at Boone District's principal office.

6. Boone District shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, it shall forward a duplicate of the notice and request to the Commission.

7. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

8. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
